



## AFFILIATE AGREEMENT

This agreement describes the terms and conditions for participation in the Jedow Interactive, LLC Affiliate Program. The terms "Affiliate," "you," and "your" are referring to you, the applicant. "We" and "our" refer to Jedow Interactive, LLC. We are independent parties and this agreement will not form any partnership.

## AGREEMENT DURATION

This agreement will begin upon our acceptance of your affiliate application and will end when terminated by either party. Termination may happen at any time, with or without cause, by giving the other party written notice of termination.

## MODIFICATION

By posting a Change Notice or a new agreement on this site, we may modify any of the terms and conditions within this Agreement at any time and at our sole discretion. These modifications may include, but not limited to changes in the scope of available referral fees, fee schedules, payment procedures and Program rules. If any of the modifications are UNACCEPTABLE TO YOU, your only recourse is to terminate this Agreement. If you CONTINUE PARTICIPATION IN THE PROGRAM following the posting of a Change Notice or new agreement, it will be considered as your acceptance of the change.

## COMMISSION FEES

Jedow Interactive LLC offers a Tiered Affiliate Program.

**Tier 1:** Affiliate will receive **15%** of the revenue on the initial sale for commission from orders placed through our website, email or by word of mouth. You also receive **7.5%** commission on any further products that client purchases over the next year (tracked by date of initial sale).

**Tier 2:** Affiliate will receive **10%** of the revenue on the initial sale for commission from orders placed through our website, email or by word of mouth. You also receive **5%** commission on any further products that client purchases over the next year (tracked by date of initial sale).

All Affiliates begin at **Tier 2**. Affiliates are upgraded to Tier 1 at the discretion of Jedow Interactive LLC based on factors including (but not limited to): number of referrals, quality of referrals and revenue generated by referred customers.

For a sale to generate a commission to an Affiliate, the customer must complete the sale, remit full payment for the service and have their project completed. Affiliate commissions will only be paid on sales which are made through qualified Affiliates.

Referral fees can only be earned between the acceptance of the Affiliate application and notice of termination. Fees will be paid on the 1st of each month by Jedow Interactive, LLC. Any returned checks, charge backs, or fees from a returned order will be adjusted in the following fee payment.

We encourage affiliates to have an active link on their website and will send them new promotions throughout the year to promote via the web, email and social media.

## ORDER PROCESSING

Jedow Interactive, LLC will be solely responsible for processing every order placed by a customer on the Affiliate and sub-affiliate sites. Customers who purchase products and services through the Jedow Interactive, LLC Affiliate Program will be deemed to be customers of Jedow Interactive, LLC. Prices and availability of our products and services may vary from time to time. Jedow Interactive, LLC will always determine the price paid by the customer. We reserve the right to reject any order that does not comply with our rules, operating procedures and policies.

## WEBSITE RESTRICTIONS

Jedow Interactive, LLC reserves the right not to accept any website into the Jedow Interactive, LLC Affiliate Program based on site content. Sites that Do Not Qualify for the Jedow Interactive, LLC Affiliate Program include sites such as sites that are:

- ◆ X- rated and promote sexually explicit materials

- ◆ Promoting violence and discord.
- ◆ Promoting discrimination based on race, sex, religion, nationality, disability, sexual orientation, or age
- ◆ Promoting illegal or questionable activities
- ◆ Violating intellectual property rights

### SPAM (UCE)
